- Completion by Design student populations
 - Part-time Pell eligible
 - 30 hours with no credential
 - Two areas of developmental education required



First Year Experience Goals

The National Resource Center for First Year Experience and Students in Transition lists the following goals for FYE programs:

- Increase student-to-student interaction
- Increase faculty-to-student interaction
- Increase student involvement and time on campus
- Link the curriculum and the co-curriculum
- Increase academic expectations and level of academic engagement
- Assist students with insufficient academic preparation

 - Ask deeper questions to connect student with resources and services




WTCC FYE Program Requirements

First Year Academy

- Developed to support FYE and CbD initiatives
 - Increased offerings of ACA 090
 - Develop curriculum for use by all ACA 090 instructors
 - Recruit and train faculty from across the college to teach AC A 090
 - Includes newly required ACA 122 for AA and AS students

Adjustments Along the Way

- 2014SP increased number of attempts to contact students in program
- 2014FA embedded more FYE requirements in ACA 090 courses
 - Led to higher completion of FYE program
- State course redesign = only two developmental areas exist
- Throughout constant adjustment on the number of sections of ACA 090



The Future of FYE/FYA

- New placement criteria = fewer students requiring two developmental areas
- New placement criteria = more students in FYE will be greatest risk
- Possible paths to growing FYE
 - Include all 2DEV students (not just FTEIC)
 - Include all student who need any DEV (with identified exceptions)
 - Include students admitted under new placement criteria



Challenges of Implementation

- Coding of identified students
 - Manual process
- Requiring ACA 090 for FYE students
 - No process in place yet
- Predicting population size continues to be difficult
 - Impacts staffing and the number of course sections offered
 - Further complicated by voluntary participants
